There is no time like the present to make your arrangements to go to Portland. Plan your vacation, get your reservations made and your funds or plastic in order.

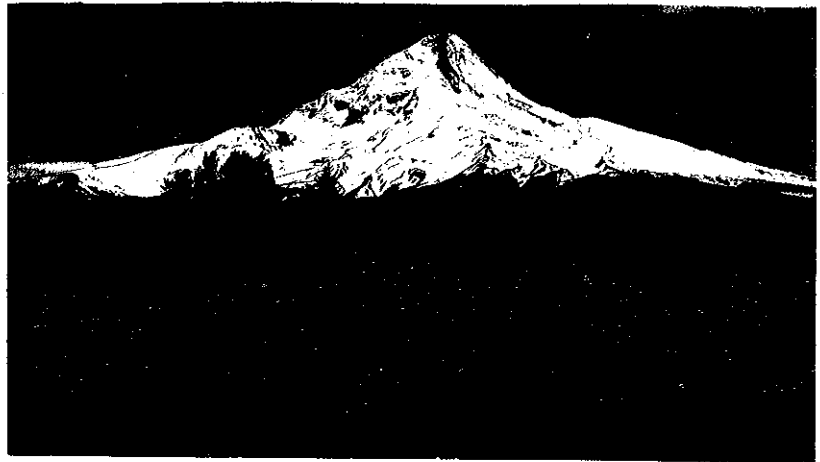
Also at this time, if you haven't sent in your idea for a TFA logo, do it soon. I know there's a lot of talent among us, so don't let it go to waste.

Robert R. Balmer

NEWARK, Del. — Robert R. Balmer, 79, of 254 Beverly Road, an environmental engineer for DuPont at the Louviers site for 32 years until his retirement in 1978 died March 13 at the Christiana Hospital after suffering a heart attack.

Born in Salem, Mass., he graduated from Northwestern University and went on to receive a master's degree in sanitary (environmental) engineering from Harvard University.

Mr. Balmer was employed by the Commonwealth of Massachusetts in the U.S. Public Health Service and the Department of Public Health for before going to work for DuPont.

A veteran of World War II, he served in the Army in the sanitary corps in Iran and Korea.

Husband of Frances Twisden Bowden Balmer, he is also survived by a son, Robert Gregory Balmer of Lebanon, N.J.; a daughter, Marilyn Frances Balmer of Laurel, Md.; and a sister, Marion Louise Chadwick of Northwood, N.H.

A graveside service will be held at 1 p.m. Saturday in Waterside Cemetery, Marblehead, Mass. Arrangements are by the Spicer-Mullikin Funeral Home, 121 W. Park Place, Newark, Del.

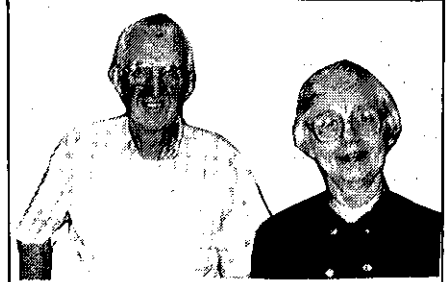

ESTE FAMILIES ON THE TEXAS FRONTIER

The rich and colorful history of the state of Texas is full of many stirring battles and events and larger-than-life individuals who made a difference in the march for Texas independence from Mexico and finally statehood. Deeply involved in these events were Edward Eugene [6] Este of the Muir Expedition and a victim of the "Black Bean Episode," and his brother-in-law, David Gouverneur Burnet, the first Provisional President of the Republic of Texas who had just assumed the office shortly before the March 1836 Battle of the Alamo.

Before exploring this branch of Esty's further, we will go back and start with the life of Edward Este's ancestress, Mary [2] Towne Esty, who also earned her place in American History.

Mary [2] Towne, daughter of William [1] Towne and Joanna Blessing, was born at Gt. Yarmouth, Norfolk Co., England, where she was baptized at St. Nicholas Church on 24 Aug 1634. Probably within the first year of her birth, William Towne removed his family by sea to Salem, Massachusetts, where he became a land owner before 1640. When Mary was 17 years of age, her father removed his family in 1651 to the new town of Topsfield, Massachusetts.

By 1655, Mary had met and married Isaac [2] Esty, who had been baptized 17 Nov 1627 in Freston, England, to Jeffrey [1] Esty and Margaret Pett. Isaac had also been brought to Salem at an early age, as his father was granted twenty acres of land there in 1636.

Isaac, a cooper by trade, bought his first farm in Salem from Job Hilliard on 2 May 1653. Before 1660, he settled in Topsfield where he was one of the commoners appointed to share in the Topsfield common land on the south side of Ipswich river. He was one of the selectmen of the town in 1680, 1682, 1686 and 1688. He was chosen juryman of trials at Ipswich in 1681, 1684-85, and in years 1691 and 1696 he was grand juryman. He also served as tything man, surveyor of highways and fences and was a member of different committees of Topsfield.

The Topsfield Church register for 1684 shows that Isaac Esty, wife and family were members in full communion.

When that terrible witchcraft delusion spread over Salem Village and vicinity, among those to fall a victim was Mary Esty. She was arrested 21 Apr 1692, kept in jail until 18 May, when she was released. On 21 May, a second warrant was procured and she was taken from her home at midnight, carried to Salem jail and placed in chains. She was tried, found guilty and condemned to death and on the 22 Sep 1692, she was executed with seven others.

She was a woman of sound judgment and exalted Christian character, and a mother of nine children, with the youngest, age 14. In intelligence, she was far in advance of her age, as her petition written while in prison, amply bears testimony. Among the words, Mary penned, she said, "The Lord above, who is the Searcher of all hearts, knows, as I shall answer it at the tribunal seat, that I know not the least thing of witchcraft; therefore I cannot, I dare not, belie my own soul."

After the sentence was executed, Isaac Esty did not weakly submit to what seemed to be the

inevitable. With a keen sense of justice and a recognition of his duties to his martyred wife, he set about doing all in his power to rescue her name from reproach and his children from disgrace. After nearly twenty long years, he was in a measure successful; the petitions which he presented to the court were recognized; the verdict annulled; and twenty pounds granted him in acknowledgement of the injustice of the previous decision.

He died at Topsfield, in 1712, leaving a will dated 26 Mar 1709, which was probated 11 Jun 1712.

Isaac [3] Esty, born in Topsfield about 1656 to Isaac Esty and Mary Towne, was married on 14 Oct 1689 to Abigail Kimball. She was born 22 Mar 1667 at Ipswich, Mass., to John Kimball and Mary Bradstreet.

Isaac's name appears with others who took the oath of allegiance and fidelity to Charles II in Jan 1677. In 1681, his minister's rate was seven shillings and one penny. In 1689 and 1691, he was chosen one of the surveyors of highways, and in 1694 was chosen constable. In 1696, he was one of the selectmen of Topsfield.

His father's will left him in ownership of the 44 acres on the south side of the Ipswich River where he resided.

He left a will dated 16 Mar 1713/14, which was probated 3 May 1714. Abigail married second, 25 Apr 1718 to William Poole of Reading. She died 12 Feb 1760 at Topsfield.

Moses [4] Esty was born in Topsfield on 6 Sep 1712 to Isaac Esty, Jr. and Abigail Kimball. He removed from Massachusetts early in his adulthood and was married on 8 Sep 1736 at Suffield, Hartford Co., Connecticut, to Eunice Pengilley.

Eunice was born at Suffield on 15 Mar 1719 to John Pengilley and Mary Granger. John Pengilley, the son of John Pengilley who was a freeman in Ipswich in 1678, removed early to Suffield, Connecticut. Mary Granger, born in 1681, was the

youngest child of Launcelot Granger (1624-89) and Joanna Adams (1634-1701), daughter of Robert Adams. Launcelot came from England to Ipswich, Mass., in 1648; later to Newbury and thence to Suffield, Connecticut in 1674.

Moses and Eunice removed to Enfield, Conn., in 1751; and in 1756 to Bucks Co., Pennsylvania. Late in life, they moved to Reddington and then Black River, both in New Jersey.

Their first seven children were born in Suffield, Conn.; and five were born in Enfield, Conn. The children, surname **Esty**, were:

Moses [5] Este, Jr. was born at Enfield, Hartford Co., Conn., on 7 Jan 1752 to Moses Esty and Eunice Pengilley.

Moses was a lieutenant of Militia in 1774 and was promoted captain. He served on tours of duty guarding prisoners and stores; was at the Battle of Monmouth, N.J., where he was wounded. In 1832 he was placed on the pension roll for service in the New Jersey line.

He married first to **Elizabeth Fairall**, who was born 8 Oct 1760. They probably had no children. He married secondly ca 1784 to **Anne Kirkpatrick**. She was born 10 Mar 1764 at Mine Brook, Somerset Co., N.J., to David Kirkpatrick and Mary McEwen, who had been married at Mine Brook on 31 Mar 1748.

Moses and Anne resided in Morristown, Morris Co., New Jersey, where their children were christened in the First Presbyterian Church.

She died 11 Nov 1811 and he died 4 Feb 1836 at Morristown.

David Kirkpatrick [6] Este was born at Morristown, New Jersey, on 21 Oct 1785 to Moses Este and Anne Kirkpatrick.

He graduated from Princeton University with an A.B. Degree in 1803 and became an attorney. Before 1820, he moved to Cincinnati, Ohio, where he set up a law practice. Later, he served as a judge in Cincinnati and subsequently, became a Justice of the Supreme Court of Ohio.

David married in 1819 in North Bend, Ohio, to **Lucy Singleton Harrison**, daughter of the ninth President of the United States William Henry Harrison and wife, Anna Tuthill Symmes.

Lucy was born 1 Sep 1800 in North Bend and just a short time after her birth, her father was sworn in as Governor of Indiana Territory on 12 Jan 1801, and the family moved to Vincennes, Indiana, the territorial capital. He fought Indians at Tippecanoe in 1811, and resigned the governorship on 28 Sep 1812 and served as a brigadier general in the U.S. Army in the War of 1812. He rose to major general in command of the Northwest. The family returned to North Bend, Ohio, and he held offices of Ohio State Senator; Superintendent of Indian Affairs; U. S. Senator; and Minister to Colombia. He was inaugurated as president on 4 Mar 1841 in Washington. He died of pneumonia on 4 Apr 1841.

Lucy died on 7 Apr 1826 in Cincinnati, and is probably buried in North Bend. David married, secondly, to **Louise Miller**. He died in 1875 in Cincinnati.

His children, surname **Este**, and all born in Cincinnati, were:

Edward Eugene [6] Este was born in 1796 at Morristown, Morris Co., New Jersey, to Moses Este and Anne Kirkpatrick.

His sister, Hannah, had married in Dec 1830 to David G. Burnet, the empresario of Burnet's Grant near Nacogdoches, Texas; and apparently he decided to follow and find a place for himself in this land still under Mexican rule. After his arrival in Texas, he was successful in receiving a grant of land from Stephen F. Austin, in his colony which came to be known as "Austin's Old Three Hundred." He was entered in Austin's ledger, as follows: "Jany 3d, 1834. Edwd. E. Este, single man from New Jersey. The land to join D. G. Burnet."

Edward married on 8 Oct 1841 in Harris Co., Texas, to Elizabeth Jane Smith. It is not known if they had any children.

On 21 Apr 1836, Texas had won independence from Mexico as a result of General Sam Houston's forces winning a decisive battle at San Jacinto against the forces of General Antonio Lopez de Santa Anna. Texas claimed the Rio Grande as its western boundary but did not have the population or military forces to exercise control over the land beyond the Nueces River, so conflicts were common between Texans and Mexicans. In Feb 1842, General Rafael Vasquez led 700 Mexican troops into Texas to attack San Antonio. After looting the town, Vasquez retreated on 7 Mar. On 11 Sep 1842, General Adrian Woll's Mexican army of 950 men succeeded in capturing the town. More than 50 Texans were captured.

When news of the capture of San Antonio reached Gonzales, Mathew Caldwell gathered a group of men to march to San Antonio. In LaGrange, men rallied and began marching toward San Antonio. Nicholas Dawson was elected captain of this latter group. Arriving within two miles of Caldwell's position on Salado Creek, Dawson and his 53 men were intercepted by 400 Mexican troops. The Mexicans showered his men with deadly cannon fire, and stayed out of range of the Texan's rifles. When the fighting ended, 36 Texans were killed, 15 taken prisoner and 3 escaped.

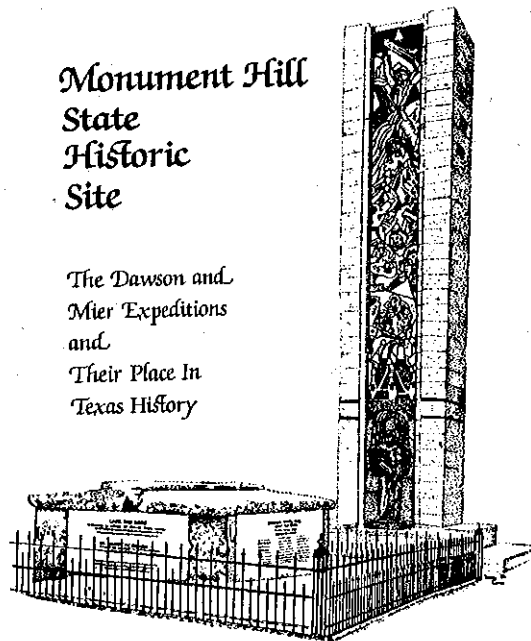
The Mexican army retreated from San Antonio on 20 Sep and recrossed the Rio Grande with the 65 prisoners on 1 Oct.

Upon learning of the raid upon San Antonio, President Houston called for the assembling of the militias to march to San Antonio to join forces under the command of Brig. General Alexander Somervell to repel the raiders. This army of 750 men, including **Edward E. Este**, left San Antonio on 25 Nov, but its forces were soon reduced by desertions. On 8 Dec, the Texan army of about 730 men, entered the deserted Mexican town of Laredo, and Somervell let another 187 men return home. After entering Guerrero on 15 Dec and being disgusted that they had not fought the enemy, about 190 more men straggled home with Somervell, but 308 loyal Texans, including **Edward Este** remained on the border.

On Christmas Day, 1842, they attacked the Mexican town of Mier, and eventually surrendered to

General de Ampudia. As the Texans were marched toward Mexico, 188 Texans made a successful break for liberty from the Rancho Salado on 11 Feb. Heading for the Rio Grande, about 200 miles away, the group left the road on the 12th in favor of traveling through the mountains. They located a water hole on the 15th, and being in need of food, killed their horses for meat. After this, no more water was found. Within two weeks after their escape, most of the men had surrendered for want of food and water. In all 176 Texans were recaptured, 7 died in the mountains, and 5 reached Texas.

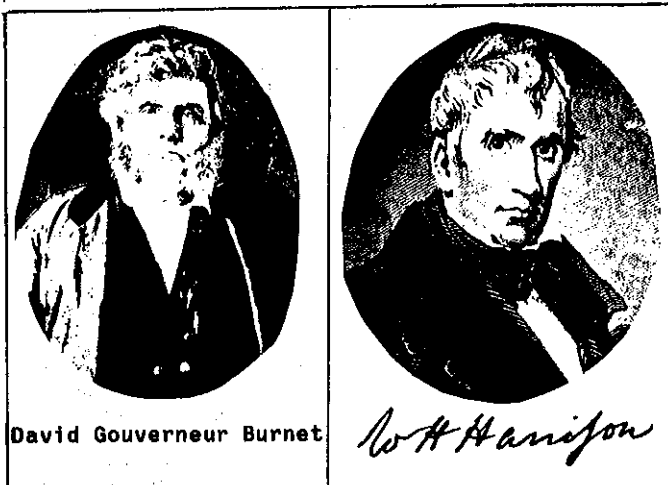
The recaptured Texans were returned to the Rancho Salado on 25 Mar 1843, and were met with an order from General Santa Anna that one tenth of them be shot. To carry out the order 159 white beans and 17 black beans were placed in a pot. Those who drew black beans were given a chance to write home, then were bound together and shot. **Edward E. Este drew a black bean and was executed on that day, 25 Mar 1843.** The balance of the prisoners taken to Perote Prison, near Mexico City, were finally released, on orders of General Santa Anna, on 12 Sep 1844.

In 1847, during the war between the United States and Mexico, Captain John E. Dusenberry, one of the members of the Mier expedition who drew a white bean, detoured to Rancho Salado and reclaimed the bones of the Texans who had been shot there. The remains arrived in LaGrange, Fayette Co., Texas, in Jun 1848, and the remains of Capt. Dawson and his men from near Salado Creek were retrieved shortly thereafter. On 18 Sep 1848, the sixth anniversary of the Dawson Massacre, the remains of these men were given a military burial in a tomb on the bluff overlooking the Colorado River, just outside of LaGrange.

Called Monument Hill State Historical Park, and now a State of Texas facility, it is yearly visited by many people, including the author of this article, and her husband, in Mar 1993. After viewing Edward E. Este's name on the monument, it seemed imperative that his linkage to

Mary Towne Esty, be discovered and his story written.

Hannah [6] Este was born at Morristown, New Jersey, on 17 Feb 1800 to Captain Moses Este and Anne Kirkpatrick. She married on 8 Dec 1830, at Morristown, to **David Gouverneur Burnet**. He was born at Newark, New Jersey, on 4 Apr 1788 to William Burnet and Gertrude Gouverneur.



David's parents died when he was very young and he was reared by his elder brothers and given a good education. One of these brothers, Jacob Burnet, became a Justice of the Supreme Court of Ohio and U. S. Senator. Another, became mayor of Cincinnati. Jacob Burnet made the

speech at the Harrisburg Convention in 1839, which nominated his friend, William Henry Harrison, for the United States Presidency.

David G. Burnet, in 1806, was a lieutenant in Francisco de Miranda's expedition to Venezuela which attempted to free that country from Spain. The expedition failed and he barely escaped with his life. On his return, he went to his brothers in Ohio, where he studied and practiced law. In, 1826, bearing letters from Henry Clay and Stephen F. Austin, he went to Saltillo, Texas and obtained from the Mexican Government an empresario's contract to settle three hundred families near Nacogdoches, Texas.

After their marriage, they settled on the San Jacinto River, and he was appointed one of the first three judges in Texas in 1834. In the winter of 1836, he was a member of the convention which issued the Texas Declaration of Independence. Two weeks later, he was elected by the convention as Provisional President of the infant Republic of Texas. In Mar 1836, the Battle of the Alamo, was waged. During his brief presidency, he faced down a military near-rebellion, moved the seat of government three times because of the Mexican army, and had to handle the disposition of the captive, Santa Anna, after the Battle of San Jacinto. In September, Sam Houston was chosen president in a regular election, and he resigned on 22 Oct 1836.

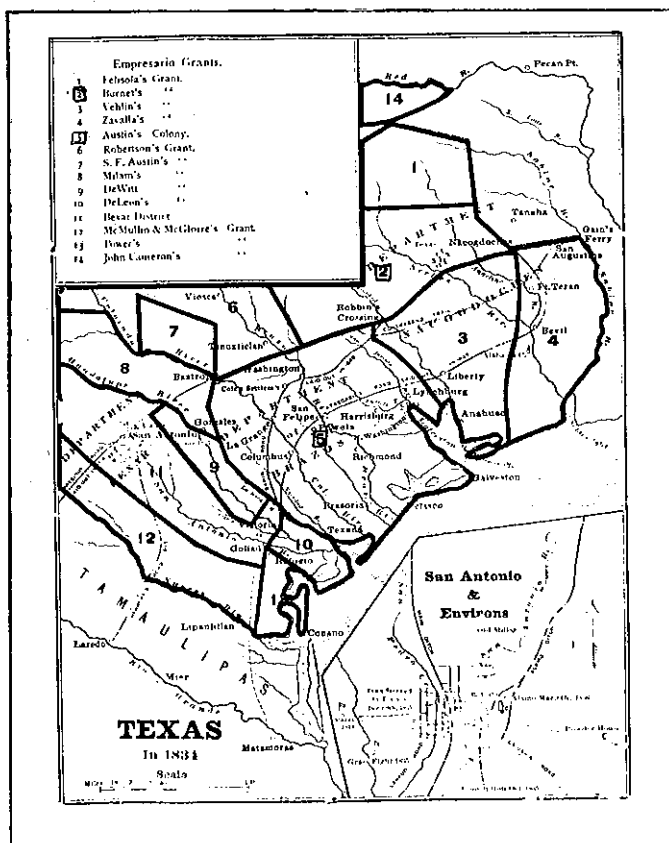
He was vice-president in 1840-42 of Texas, and during Lamar's administration, he acted as secretary of state and later as president because of Lamar's illness and absence from the Republic. Again, he was secretary of state from 1846-1847, under the first Governor J. P. Henderson. He opposed secession during the Civil War. In 1866, he was elected to U.S. Senate by the 1st Reconstruction Legislature, but was not allowed to take his seat. In 1868, he was a delegate to the national Democratic convention in New York and was a presidential elector.

By 1850, he had lost all of his children except one, and Hannah died on 30 Oct 1857 leaving him disconsolate. His remaining son, William, as a Confederate, died in the battle at Mobile in 1865. David died on 5 Dec 1870 at Galveston, at age 82.

ENGLAND IN 1994

There has been interest expressed by several members in another visit to England and the areas where people named Towne once lived. This involves the English East Anglia counties of Kent, Suffolk and Norfolk east of London.

A meeting was held with Jim Bolles of Family Society Tours, LTD., Jean Warner, Marie Roome and myself at Jean's home back in February to discuss the proposed trip. I suggested that the stopovers would be three nights long rather than two nights as it would be less wear and tear on the travelers (less unpacking and repacking).

We would possibly stay at major research centers such as Canterbury, Norwich, Maidstone, Bury St. Edmunds and London for instance. Also, Towns Place, (parts of which were built in 1414), Leanord Towne's farm (built in 1653, the initials L.T. 1653 are carved in a stone on the barn.) at Braceby. Across the road from the farm is the tiny parish church where the tombstone reading "Here Leys the Body of Ann Towne Wife of Richard Towne Brvary 1630." We could visit the Parish Church in Nettlestead which contains which contains a stained glass window with the Towne Coat of Arms empaied with another family. We would visit the Haydore Parish Church where a family of Townes lived for many years. The old Haydore Church register still exists in the Lincoln Archives and it has also been published which can be found in the Society of Genealogists library in London.

Those of you who plan doing research should let me know very soon so that proper arrangements and planning can be made. Some places require pictures and other procedures ahead of time.

This trip may have another interest to our members who might have served in WW2 in England. Several WW2 50th anniversary programs are going on at various places during the same time that we will be there. It is interesting to visit some of the old locations where the 8th Air Force airfields used to be for instance.

RAY ARTHUR TOWNE OF COLORADO

Ray Arthur [9] Towne, born 18 Feb 1890 to Salem Henry Towne and Agnes Calderwood in Washington Twp., Crawford Co., Iowa, married on 22 Jun 1916 in Ashland, Nebraska, to Vera (Montgomery) Railsback. She was born 10 Mar 1886 in Cass Co., Illinois, to Henry V. Montgomery and Florence N. Rodd.

Ray was in the banking business for most of his life. He moved to Hillrose, Colorado, in 1917, where he was in the banking business eight years. On 17 Feb 1925, the Security State Bank in Sterling, Colorado, was opened with Ray A. Towne, vice president and cashier. He soon became president of the bank and gained prominence as head of the institution.

Little did he know, that he would become part of the most talked-about occurrence of the 1930's in Sterling...the robbery of the bank by a gang of machine-gun bandits on the morning of 11 Apr 1934. Afterwards, it was generally agreed by officers and witnesses that the robbery was by experienced bandits but not by any of the notorious gangsters like John Dillinger or Clyde Barrow.

The bandits, three or four in number and all masked, smashed the glass in a side door and turned the spring lock on the door and walked in. Compelling the assistant cashier, L. B. Propst, to open the safe within the big vault, the bandits emptied the strong box of more than \$33,000 in cash, currency and securities. They escaped to their car, taking Ray A. Towne, president, Propst and Davis Morrell, a teller, as hostages.

At machine gun point, the hostages were made to climb on the running boards of a Chevrolet sedan car of dark green, and the driver sped down Main Street to Front, thence to Chestnut and then east on Highway No. 6. In a few minutes several people went in pursuit of the bandit car, and all failed to catch it. They did soon come upon the three bank officials standing on the highway, two or three miles east of town.

The bandits had exchanged their stolen car in which they perpetrated the robbery for another automobile which had been hidden in a clay pit alongside the highway. From that point, they escaped. While the alarm was spread across the country, law officers, pilots and many other citizens launched a search for the outlaws, but none were found.

Ray died on 22 Jul 1964 and Vera died in Nov 1967 in Sterling, where they are buried in Riverside Cemetery there.

William [5] Towne, born at Middleton, Essex Co., Mass., on 10 May 1736 to Daniel Towne and Dorothy Dorman, married on 22 Mar 1763 at Danvers to **Mary Smith**. She was probably the Mary born on 22 Mar 1742 at Ipswich to Francis Smith and Mary Fellows.

William was on the Danvers tax list in 1775. Known as Capt. Towne, he bought a pew in the church in 1787 and again in 1806 at Danvers. He had a family of five in the 1790 Danvers census.

In 1755, he was a sergeant in Capt. Andrew Fuller's Co. of Danvers, Col. Paisted's Regt. He marched as a 2nd Lieut. in Capt. Israel Hutchinson's Co. of Danvers, on the Lexington Alarm on 19 Apr 1775. This company had several men killed and wounded. He was commissioned Captain of the 2nd Co., 8th Regiment, Essex Co. Militia on 9 Jun 1778, and was on the List of Officers.

Mary died at Danvers on 30 Jul 1843 at age 101 yrs. 4 mos. 9 days. (VR's.) William died between 1806-1810 at Danvers.

William [6] Towne, born at Danvers, Essex Co., Mass. in 1778 to William Towne and Mary Smith, married ca 1799 to **Sarah Flint** at Danvers. She was born on 17 Dec 1780 at Danvers to William Flint and Mehitable Peabody, who had been married on 4 May 1780 at Danvers.

William and Sarah lived first at Danvers where all of their children were born (Danvers VR's). Between 1830-31, he removed most of his family to Natick, in Middlesex Co., Mass. By the time of the 1850 census (p 354 Natick), most of the males in the family were engaged in shoemaking for a manufacturer who was also their brother-in-law, Ephraim Hayes. The Townes who all lived next door to each other were the families of Amos Harrington, Ephraim Hayes, Wm. R. Legro, and Benjamin Towne. Widowed mother, Sarah Towne, and son, John, were living with Benjamin Towne. Daughter Phebe's husband, Henry Parker, was also a shoemaker but their family had remained in Danvers (p 36, 1850 census, Danvers, Essex Co.). Another daughter, Lydia, was married to John Colbath, who was the half-brother of Vice-Pres. Henry Wilson who was in the second administration of President Ulysses S. Grant in 1873-77.

Natick vital records show William's death as: "Capt. William Towne, d March 9, 1843, age 64." Sarah was still living in 1850.

She was married on 30 Nov 1828 in Danvers to **Henry Parker** who was born 4 Sep 1796 in Wakefield, Middlesex Co., Mass. to Ebenezer Parker and Lucretia Richardson. Phebe was Henry's second wife. He was first married in Danvers on 12 Apr 1816 to Judith Brown.

FRANKLIN D. ROOSEVELT'S LITTLE WHITE HOUSE
WARM SPRINGS, GEORGIA

The "Little White House," located on a beautiful site on the slopes of Pine Mountain, tells much of the nature of the man who played such an important role in the history of this country and of the world. This is also the place where President Franklin D. Roosevelt died on 12 Apr 1945.

Shortly after the Little White House was opened to the public in 1948, all the states--then forty-eight in number--were invited to contribute specimens of native stones for a planned "Walk of the States." But when the first stones arrived it was found they differed so in texture and degree of hardness, as well as form, that their use in a walk would be impractical. So, the plan was changed and the specimens, as they arrived were displayed on sturdy bench stands, each identified with a permanent marker showing the type of stone and state from which it came.

There, in the central area, they remained until early in 1961 when they were moved to their present locations flanking the ornamental walkway leading to the museum. In 1964, the flag of each state was placed above the stones.

The stone from Maine is described, in the Souvenir Tour Guide from the Little White House and Museum, as:

"MAINE--Fine gray granite in unfinished state. This type, chiefly used for paving blocks, is known as Clark Island Maine Granite. It was contributed in 1950 by A. C. Hocking, of Clark Island, through Winfield C. Towne, Kennebunkport attorney, a polio victim who was able to walk with aid of crutches and who had attended the dedication of the Little White House ceremonies in 1947. He paid the shipping charges on the stone."

THE

JOSEPH KIMBALL FAMILY.

FIRST GENERATION.

RICHARD KIMBALL.

I. RICHARD was probably the ancestor of most of the numerous families of the name of Kimball in New England.

On the tenth of April, 1634,* O. S., at the age of 39, he embarked at Ipswich, in the county of Suffolk, Old England, in the ship *Elisabeth*, William Andrews, master, for Massachusetts, and landed at Ipswich in New England. He first settled in Watertown, of which he was a proprietor, in 1636-'7; was admitted a freeman 6 May, 1635.

[On the map in the history of Watertown, by Henry Bond, M. D., the homestead of "R. Kimball" of six acres where he first settled, is bounded N. by Cambridge, E. by land of W. Hamlet, S. by the highway, and W. by land of Edward White.]

*History of Watertown, Mass., by Henry Bond, M. D., but the "Historical Memo-randa" gives the time "last of April."

There came with him his wife, Ursula (Scott) Kimball, and seven children; also, at the same time, in the same ship, the mother of his wife; Martha Scott, who was born in 1574; his brother Henry, aged 44, and his family, consisting of his wife Susanna, aged 35, and children, Elisabeth, aged 4, and Susanna, aged 1½ years. Besides the foregoing, Thomas Scott, brother-in-law to Richard, aged 40, his wife Elisabeth, aged 40, and children, Elisabeth, aged 9, Abigail, aged 7, and Thomas, aged 6, were passengers on the same ship. They settled in Ipswich.

Richard soon after removed from Watertown to Ipswich, and is first known as an inhabitant of that place 23 Feb., 1637-'8, when he was granted by the town "a house lott next adjoining to Goodman Simons at the west end of y^e town;" also granted him the same day "40 acres Beyond the North River near the land of Robert Scott." In 1639-'40, he had "liberty to pasture two cows free." He is mentioned "the last day of last month 1641," as among the commoners of Ipswich, and appointed, 1 March, 1645-'6, as one of the "Seven men." 19 Dec., 1648, he subscribed with others 3s. as his annual proportion towards the sum of 24*l* 7s. as a rate for the services of their military leader, Major Daniel Dennison, then commander of the military forces of Essex and Norfolk counties.

His occupation was that of a wheel-wright. January, 1649-'50, he was granted liberty "to fell such white oaks as he hath occasion to make use of about his trade for the towns use." Also, 1660, "to fell 20 white oak trees to make weels for the Townsman

their use." September, 1652, he and Robert Lord were appraisers of the estate of John Cross. In 1653 he was of a committee of three to survey fences in the common fields north of the river.

He was joint executor of the will of his brother-in-law, Thomas Scott, Sen., who died February, 1653-'4, in which instrument he is mentioned as brother Richard Kimball, whom he appoints, with Edmund Bridges, executor. Shortly after, 25 May, 1654, their official trust and obligation were recognized by Thomas Scott, Jr., then a resident of Stamford, Conn.

He married Ursula, the sister of Thomas and daughter of Martha Scott, before his arrival in Ipswich. Married, 2d, Margaret, widow of Henry Dow, of Hampton, 23 Oct., 1661. Margaret died 1 March, 1675-'6. Richard died 22 June, 1675, leaving a will dated 1674-'5. His age was 80 years.

The children of Richard and Ursula [Scott] Kimball were,—

2. URSULA,* b. in England, d. in Salisbury, Mass., 17 June, 1658.

* Mr. Rantoul, in his notice of James Kimball, gives Ursula as the oldest child. Mr. Stickney omits Ursula, and names Henry as the oldest child, but says there was a daughter.

3. HENRY, b. in England, 1619, m., 1st, Mary Wyatt; m., 2d, Elisabeth, dau. of Thurston Raynor. She came to New England in the ship *Elisabeth*, when 9 years old, with Henry, her future husband, who was 15 years old. He removed to Wenham about 1655, and d. about May, 1676.

4. ELISABETH, b. in England, 1621, m. John Severens.

5. RICHARD, b. in England, 1623.

6. MARY, b. in England, 1625, m. Dea. Thomas Knowlton, 17 May, 1682.

7. MARTHA, b. in England, 1629, m. Joseph, son of Philip and Mary [Winslow] Fowler, who was b. 1622. Joseph was killed in battle with the Indians near Deerfield, 19 May, 1676. (A full history of Joseph is given in the "Fowler Family," published in 1883 by Matthew Adams Stickney, Esq., of Salem, Mass.)

8. JOHN, b. in England, 1631, m. Mary, dau. of Humphrey and Bridget Bradstreet, about 1665; m., 2d, Mary, dau. of Francis and Jane [Wilson] Jordan, 8 Oct., 1666. John d. 6 May, 1698.

9. THOMAS, b. in England, 1633, was a wheelwright; m. Mary —; removed to, and was one of the first settlers of, Bradford, Mass., where he was killed by the Indians 3 May, 1676. His wife and five children, viz., Joanna, Thomas, Joseph, Priscilla, and John, were taken prisoners, and carried forty miles into the wilderness, but were returned on the 13th of June the same year.

10. SARAH, b. in Watertown, 1635, m. Edward Allen, of Ipswich, 24 Nov., 1658. They had eight children.

11. BENJAMIN, b., probably in Watertown, 1636-'7; removed to Salisbury, where he was living in 1661-'2, thence to Bradford; m. at Salisbury Mercy, dau. of Robert and Ann Hazeltine, 16 April, 1661. Ann was b. in Bradford, and d. 5 Jan., 1707-'8. She was one of the first members received into the first church in Bradford, 7 Jan., 1682-'3. Benjamin d. 11 June, 1696.

12. CALEB, b. in Ipswich, 1639, m. Anne, dau. of Robert and Ann Hazeltine, of Bradford, 7 Nov., 1660. Caleb d. 9 April, 1688.

PAUL M. TOWNE

Paul M. Towne of 1408 Antero Drive, Loveland, Colorado, died Thursday, 30 January 1985 at Bath Israel Hospital in Denver. He was 74.

Towne was born in Santa Monica, California, on 26 March 1910. He was educated at Iowa State University and the University of Oregon.

Shortly after his marriage to Thurla Healy on 6 March 1929, the pair farmed until World War II when Towne became an Air Force Cadet. Following the war, Towne went into heavy construction work.

During the 1950's, he was the architect's representative during construction of the University of Wyoming.

His construction vocation took Towne across the globe including Iceland, Labrador and North Africa. In Vietnam, Towne was project manager for the construction of Highway No. 1, and in Thailand, he served as project engineer in the construction of a B-52 pad.

Following his retirement in 1969, the Townes settled in Australia and New Zealand before moving to Loveland, Colorado in 1970.

Mrs. Towne preceded her husband in death on 5 April 1977.

Towne is survived by two sons, Gordon B. Towne of Wheat Ridge, Colo., and Stanley R. Towne of Titusville, Fla., seven grandchildren and one great-grandchild.

He was a member of the First Christian Church where funeral services, officiated by the Rev. James P. Adams will be held Monday at 10:30 a.m.

Towne will be buried in Loveland Burial Park. Hunter Funeral Home is in charge of services and arrangements.

Tracking 17 million names

NEW YORK, N.Y. — The estimated 100 million Americans whose relatives arrived in the United States at Ellis Island will be able to trace their history at a new computerized genealogical center planned for the restored immigration site.

The new computer project, being organized by a private group, will contain information on the 17 million immigrants who landed at Ellis Island, including the date they arrived, the ship they came on, their country of origin, their physical characteristics and even the amount of money they brought to the New World. All a user would need to

know is the relative's name.

A special program now being developed would automatically help visitors whose relatives' names had been changed or spelled phonetically by American immigration officials.

Plans to raise funds for the \$25 million family history center were announced last week by the non-profit Ellis Island Restoration Center, which has worked with the Statue of Liberty-Ellis Island Preservation Foundation to restore Ellis Island and turn it into a museum.

The initial stages of the museum are scheduled to open in the fall of 1989, with the genealogical computer to be ready for use in 1992, the centennial of Ellis Island.

At the same time, Navy divers have begun efforts to refloat a ferry that carried most of the immigrants from Ellis Island to the shores of New York and New Jersey.

The ferry, named the Ellis Island, sank at the ferry slip on the island in 1968, 14 years after operations at the island were ended. From 1904, when the 144-foot double-decked ferry was put into service, it carried 12 million immigrants from Ellis Island to the Battery in lower Manhattan or a railroad terminal in Jersey City.

Edie Shean-Hammond, a spokeswoman for the National Park Service, which will operate the Ellis Island museum, said the sunken ferry had to be removed because it represented a navigational hazard to efforts to build a new ferry slip on the island in preparation for the reopening of Ellis Island next year.

When the project was first proposed, Shean-Hammond said, private contractors said raising the ferry would be too costly or would lead to its breaking up under water. Then the Navy volunteered its services free as part of a training program.

Towne House Moves to 629 Oakland Avenue

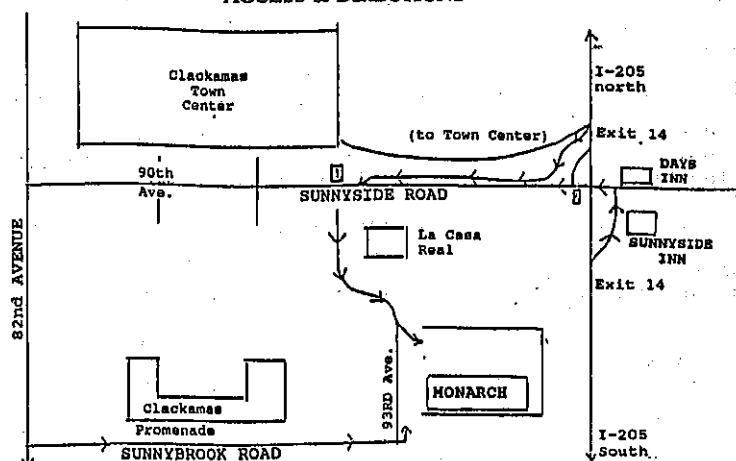

Although we have raised \$415,000 towards our goal of \$850,000, the Towne House Capital Campaign still needs your support.
